On October 16, 2023, Tishk International University's International Relations and Diplomacy Department hosted a workshop on "Conflicts: Types and Implications", aligning with SDG 16 (Peace, Justice, and Strong Institutions). Dr. Ali Mazoudji and Dr. Mohammad Salih Mustafa examined interpersonal, structural, and societal conflicts, emphasizing their impact on peace and justice. They highlighted leadership, communication, diversity, and social justice as key tools for conflict resolution, reinforcing SDG 16's goal of fostering peaceful and inclusive societies.

On October 19th, 2023, Tishk International University hosted a National Workshop on the "Israel-Palestine Conflict: A Call for Peace," aligning with SDG 16 (Peace, Justice, and Strong Institutions). The workshop examined the historical and geopolitical roots of the conflict, tracing back to the 1917 Balfour Declaration and the 1947 UN Partition Plan. Panelists highlighted ongoing tensions, including the October 7th attack, and its global implications. Recommendations for peace included the implementation of a two-state solution, a ceasefire, and respect for international humanitarian law, reinforcing SDG 16's goal of fostering peaceful, inclusive societies and addressing global conflicts.
